

PROGRAMS OF EXCELLENCE

As the oldest and largest agency of our kind in south central Indiana, Stone Belt has been providing innovative supports and education to individuals with disabilities since 1959. Begun by nine visionary families wishing to create educational opportunities for their school-age children, Stone Belt has grown to include residential programs, employment resources, life skills and vocational training, and clinical services, all which enable individuals to live self-directed lives of significance and meaning. Stone Belt has remained at the forefront of the field — pioneering essential changes, and implementing programs that touch thousands of lives each day.

Our community is stronger when every individual experiences success. Stone Belt embodies core principles that empower and support all people to experience their greatest potential — These values are utilized to reach toward excellence every day at Stone Belt.





Hand in Hand

The Hand in Hand Project is a collaborative effort between Stone Belt clients and the community. The project involves daily collections and donations of non-perishable food, contributed by community members and collected by Stone Belt clients. The project feeds thousands of people and provides community members with a valuable lesson about the ability of everyone to truly make a difference. The clients are successfully contributing to the strengthening of society through substantive professionalized volunteer employment. Hand in Hand is growing in all four Stone Belt service regions, providing opportunities to ever greater numbers of individuals to meaningfully engage with the community.

Stone Belt Arts

Incorporating both creative expression and skill utilization, Stone Belt Arts provide individuals with disabilities the opportunity to explore the performing arts, develop careers as artists and artisans, and learn valuable skills in support roles related to art development and production. Fine art pieces, hand-made crafts and finely-crafted wood furniture are designed and manufactured by individuals with disabilities in the Art & Craft line. Stone Belt artists are also represented in art installations in public spaces throughout south central Indiana. Clients engage in creative experiential learning in all areas of the performing arts.




Milestones Clinical & Health Resources

The Milestones program provides psychiatric services, behavioral supports, innovative therapies, social work resources and clinical nursing for individuals with developmental disabilities, as well as for children and adolescents. Specializing in the Autism spectrum, play therapy, and positive behavioral interventions, Milestones has become a leader in the mental health field, enabling individuals to experience health and balance in their lives.

Life at Home

Stone Belt's residential program supports hundreds of individuals to live fully in the community in both independent and group home settings. A comfortable and welcoming home is foundational to a successful life. Residents and staff work together to create warm and inviting home spaces that reflect residents' interests and styles. Stone Belt strives to support clients to take pride in their homes, and to feel a sense of ownership.




Life Skills and Vocational Training

Stone Belt's educational curriculum is focused on the belief that obtaining information and skills gives a person more personal power. Stone Belt offers life skills and vocational training in areas suitable to each individual's interests, age and cultural background and occur both in classroom settings and activities in the community.

Stone Belt's Manufacturing Services program provides vocational training that allows clients to learn the skills and work ethic necessary to complete job tasks and gain and maintain community employment if they choose. In the process, clients earn a paycheck for their hard work.

Community Employment

Stone Belt's Community Employment program creates an empowered workforce. Working in partnership with area businesses, the program assists individuals with finding jobs and receiving on-site training. Community Employment clients are supported in establishing relationships with their co-workers, and given the tools they need to experience success and longevity in community careers.

The Arts

“The Arts” mean so many different things at Stone Belt. When we talk about The Arts, we mean the incredible products being created by our professional client artists in our Art & Craft line of mosaics, cards and woodwork. We also mean the fabulous art exhibits that have been on display at locations throughout the city, county, and region.

The Arts at Stone Belt are also represented through hands on art experiential education, and in the collaborative art pieces that have become permanent outdoor installations, beautifying our community.

The Arts at Stone Belt are now expanding to include more than just visual arts. Performing arts of all kinds are empowering our clients to express themselves in new, creative, dynamic ways.

In past year, our artists have exhibited their pieces in shows throughout South Central Indiana, including:

Our artists have a significant following, and are regularly hailed for their unique view point and beautiful detail. They are recognized as artists, just as they should be.

Stone Belt is so pleased to have such an art fan in the City of Bloomington. The Parks and Recreation Department has regularly called upon our Stone Belt artists – in collaboration with community artist Joe LaMantia – to create whimsical, colorful permanent outdoor installations.

Stone Belt clients painted iron gates have been installed as part of the fencing of the new tots play area at Bryan Park here in Bloomington. Children are greeted by a smiling horse and a gliding airplane to stoke their imagination in play.

The Bloomington Entertainment and Arts District also undertook a project to interject art into everyday down town, including the painting of electrical boxes by local artists. Stone Belt was selected to create one such box, which served as a collaborative experience for several of our client artists.

A new Stone Belt art installation piece is located at a focal point on the soon-to-be inaugurated B-Line Trail. Utilizing former railway tracks along several miles in Bloomington, the trail will be accessible to all community members, and will be lined with park areas, benches, and dramatic art pieces. Standing ten feet tall and painted in vibrant colors on wrought iron, the gargantuan animals will welcome people as they experience the outdoors and downtown Bloomington.





Community Connections

Run With Me 5K

Our Third Annual Run With Me 5K, held in April, brought together close to 500 people for athletic competition, celebration, and friendship. Now a much-loved part of Stone Belt's culture and tradition, we look forward to Run with Me each year not only to bring much needed dollars to the agency, but also to create educational and relationship building opportunities for the community. This year saw record contributions from both corporate sponsors and individual donors.

Down Syndrome Family Connection Event

In March, Stone Belt partnered with the local chapter of the Down Syndrome Family Connection to host a book sale, art show and book reading at Barnes & Noble Bookseller in Bloomington. Shoppers had the opportunity to hear one of our talented and energetic clients, Betsy Higgins, expertly read a beautiful story about growing up as a child with Downs Syndrome. They also were invited to view some of the latest works of art coming out of our Art & Craft program, and to help create a beautiful mosaic banner that was then donated to the Down Syndrome Family Connection for use at their future events. Many shoppers also chose to purchase books in the name of Stone Belt, and to also purchase books for donation to the family resource library of Milestones Clinical and Health Resources.

Milestones

One of the most effective tools Stone Belt has for creating community connections is through our Milestones Clinical & Health Resources.

Now in its 4th year as a distinct division of the agency, Milestones reaches out across the whole of the community to help people live healthier lives. Our staff of several dozen include board-certified psychiatrists Dr. Melinda Weakley and Dr. Lia Kettenis, as well as therapists, social

workers, behaviorists, and nurses. The vision and expertise of the Milestones leadership and staff is unparalleled. Stone Belt is truly on the cutting edge of mental health and clinical supports in the State of Indiana.

Last October, Milestones held its first open house event, in order to introduce the community to its two doctors, its updated facility, and the expanded program of services.

The open house brought together representatives from the medical community, partner agencies, city leadership, and the university community for an opportunity to network and to learn about all Milestones has to offer.

Hand in Hand Project

This past fiscal year saw a tremendous expansion of the Hand in Hand Project, an exciting professionalized volunteer program for Stone Belt clients. Each day of the week, clients throughout our four-county service area travel around to the homes and offices of participating community members in order to pick up donations of non-perishable food. The food is then donated to food banks and community kitchens in each of the local communities, significantly increasing the amount of food contributions made throughout the region.

Congratulations to Don, Carol-Anne and Jonathan Hossler, who were selected as one of 20 families across the nation by the Auntie Anne Pretzel Foundation as an exemplary volunteer family, for their work in founding the Hand in Hand project. Stone Belt nominated them for this distinction, and as a result received \$2000 for the program.



Partnerships

Stone Belt is fortunate to have so many dedicated and generous community partners. The collaboration Stone Belt experiences with them touches every part of our agency.

This past year introduced Stone Belt to the men of Pi Kappa Phi fraternity on the campus of Indiana University. These incredible students have selected Stone Belt as a local charitable organization that they wish to support through their time, talent and creativity. The connection with this organization has resulted in an infusion of a new level of joy and energy in the agency.

Pi Kappa Phi's national organization sponsors the Push America bike ride across the country, raising dollars in support of agencies working with individuals with disabilities. For the past four summers, the Push America riders have selected Stone Belt's Central Region facility as a stopping point

on their ride. Twenty five cyclists ride into town and spend the afternoon with our clients and staff - eating, socializing, playing games, and enjoying one another's company.

In the past twelve months, the local chapter of Pi Kappa Phi stepped it up a notch. They volunteered at our Fall-o-Ween celebration, hosted a dinner dance at their fraternity house for several dozen clients, and provided virtually all of the volunteer labor needed to make Run with Me a huge success.

The enthusiasm and sincere enjoyment that they bring to their interactions with clients is infectious. Stone Belt looks forward to enjoying these events with them again this coming year, and to welcoming them back into our community every chance possible.



FISCAL YEAR 2008 LEADERSHIP

The Stone Belt board of directors consists of 18 elected members, including representatives from Lawrence and Owen counties, as well as a Stone Belt client. According to board bylaws, at least five members must be parents or guardians of persons with developmental disabilities. Each year the board of directors adopts a written service plan with identifies goals, objectives and policies to promote Stone Belt's mission. The board also evaluates the effectiveness and efficiency of Stone Belt programs.

Stone Belt's executive team represents staff responsible for each program or service within the organization. These individuals are charged with managing the day-to-day activities of the organization.



(*\$ in million*)



DEVELOPMENT UPDATE

Neighborhood Assistance Tax Program

The State of Indiana awarded Stone Belt \$20,500 in NAP tax credits in July of 2007, and were able to pass along these tremendous tax savings to our generous donors. Stone Belt donors utilized the entire allocation in less than a 6 month period, raising \$41,000 in support of Milestones Clinical and Health Resources. Because of this generosity, Milestones was able to provide approximately 1800 more hours of clinical supports in 2008.

The Davee Foundation

Stone Belt received a grant of \$5000 from the Davee Foundation of Chicago for the purchase of cutting-edge curriculum and equipment for the Career Advancement Services day service program.

United Way Capacity Fund

Stone Belt received a grant of \$5620 for the purchase of a commercial foil imprinting machine that will enable clients to emboss a variety of items including leather goods, ribbon, tubing, stationary and more. This equipment will enhance the products created in Stone Belt's Art & Craft division.
